You can continue to reinvent history, but I have actual records that state otherwise.

Letter- 9/27/2025

Peter- on multiple occasions I have stated that I don't want to fight with you. In fact, I held off on holding you accountable for a multitude of things, for the sake of my own health. I cannot leave this place, if I am too sick to function. But instead of remaining civil, you choose to harass me, repeatedly violating my privacy and exposing me to animal waste and pests. You also physically intimidated me by blocking the entrance of the gate. Now you are trying to control and further demean me. You are on some disturbing path to harm me, and I no longer feel safe. You have crossed the line of normal social convention. Your actions are so deviated from the norm - and unpredictable, I have had to turn outside, for my own safety. You do not appear to have any insight.

I am only going to say this once more. I AM REALLY SICK. Acute on Chronic. I am so sick, multiple experts have deemed me disabled. I am so sick, I am homebound. While I don't know what caused this, and I am in a never ending quest to figure out the why me, there is one thing that is certain; I suffer from chronic adrenal insufficiency. This means that I don't make stress hormone, and physiological distress (infection and harassment) can and has put me into adrenal crisis. In fact, I have been hospitalized on multiple occasions in this setting.

When this happens, I become so sick, I am unable to recognize it, which is why there is such a high mortality. So, much of my treatment revolves on PREVENTING adrenal crisis. This is not always possible, When the ceiling collapsed, I was already in bereavement, and that entire experience- sent me into a documented crisis. In good faith, I related this to you. But you did not even feign concern. You repeatedly relayed only financial concern. To be clear, In the middle of my medical deterioration, the ceiling in MY apartment collapsed, my property was ruined, and my landlord expected me to just move, for his financial convenience.

If you continue to harass me, my family will hold you accountable. Your behavior meets criteria for bad faith. This may have worked for other tenants, but it can kill me. So, I am formally requesting a temporary accommodation, this week, that limits your complaints/demands to things I can directly control. I ask that you do not come on the property I lease from you, or your pets, bc I am vulnerable to fungal and bacterial spores, and I already had ringworm this year- in my distal leg. I was previously treated for 9 months for a fungal infection. I am informing you, that at this moment, I am medically unwell and your intentional misrepresentation, bad faith, and harassment is an immediate threat to my health. I am not ignoring your demands, but since I am too sick to effectively debate my basic human rights, I will retain an attorney. In the absence of a formal resolution, while I get over this acute deterioration, I am requesting that you limit your communication to emergencies and do not continue to expose me to waste.
